
# TEXAS EMISSIONS REDUCTION PROGRAM (TERP)

**TERP HAS ONE PURPOSE: TO REDUCE EMISSIONS OF NITROGEN** OXIDES, A PRECURSOR TO OZONE.

TERP was established through legislation in 2001. TERP grant programs provide financial incentives to individuals, state and local governments, corporations, and other legal entities to upgrade or replace their older, higher emitting vehicles and equipment with newer, cleaner vehicles and equipment.

#### **REVENUE FOR FY 2022-2023**

• Revenue from TERP fees exceeded \$526 million for FY 2022-2023 biennium, with more than \$341 million allocated for TERP programs and administration, and over \$184 million transferred to the state highway fund for congestion mitigation and air quality improvement projects.



#### **REVENUE BREAKDOWN**

There are 5 different fees and surcharges that make up how the revenue is generated:

- Surcharge for sale or lease/rental of off-road heavyduty equipment
- Surcharge of the total consideration on sale or lease of on-road diesel vehicles over 14,000 lbs
- Surcharge on registration of truck-tractors and certain commercial motor vehicles
- Portion of the vehicle certificate of title fee
- A \$10 fee on commercial motor vehicles required to have an annual safety inspection.

#### FIND IT & FIX IT INITIATIVE

State found that there were significant increases in the number of emissions events reported and increases in the quantity of emissions reported from oil and has facilities in the Permian Basin.

After a review of the causes included in the self-reported emissions events report, it seemed to indicate that some events may have been incorrectly classified as "emissions events."

Initiative allowed owners and operators to evaluate their operations and current air authorizations to ensure that future incidents of excess emissions were reported correctly.

The Audit Act also provides certain immunities from administrative or civil penalties for violations voluntarily disclosed and corrected within a reasonable amount of time.
