Carbon Capture Utilization and Sequestration

Mr. Bret Estep Vice President of Development Tenaska

Energy markets across the US are experiencing unprecedented growth rates and new project demands. And, there is "no free lunch" when it comes to safe, reliable, affordable, and secure energy supplies. States, governments, and nations that solve the inherent tradeoffs will be the most successful in protecting the rates and service to consumers/citizens while attracting new economic growth. The interplay of CO2 storage and gas fired generation development is the key to long term, flexible, adaptable energy policy.

Ms. Jaclyn Presnal Vice President, New Energy Ventures Williams

CCS projects are challenged by undefined and uncertain state level policies. Permit reform would catalyze the development of the CCS economy giving developers a clear path to success.

Electric Markets Redesign and Performance-based Rates

Dr. David Dismukes Professor Emeritus, Center for Energy Studies Louisiana State University

Dr. Dismukes will address recent changes in electric power markets and how proposals for alternative regulation and the energy transition impact certain customer classes, particularly the larger customer classes in which the oil and gas industry typically take service. Dr. Dismukes will address how electricity rates and service provision impact, and are important to the health of all aspects of the oil and gas industry.

Consumer Focus Energy Systems

Mr. Dusty Monks Deputy Director, Policy & Research Utah Office of Energy Development

National and regional policy decisions are currently distorting energy markets by overshadowing consumer voices, leading to a misalignment with the fundamental purpose of energy production—to serve the needs of the people.

UAB Seminar: The Energy-Water Nexus

Dr. Rob Sowby Assistant Professor Brigham Young University

Water and energy are critical to national security, public health, and economic prosperity. We have treated them like they are independent resources when in fact they depend on each other. The future of both depends on the water-energy nexus: how much energy we use to produce water, and how much water we use to produce energy.

Spent Fuel Challenge

Mr. Manuel Camargo Jr. Principal Manager, Strategic Planning Southern California Edison Company

Mr. Tom Isaacs Advisor to Southern California Edison for Nuclear Waste Southern California Edison

Federal law required the Department of Energy to begin disposing of spent nuclear fuel in a deep geologic repository by 1998. Despite \$46 billion (including interest income) in contributions to the Nuclear Waste Fund, no federal facility is available to accept spent fuel that remains stranded at 76 sites in nuclear energy producing states. Lack of federal solutions to the back end of the fuel cycle an impede the deployment of next-generation, small modular reactors. Southern California Edison Company, decommissioning agent for the shuttered San Onofre Nuclear Generating Station (SONGS), partnered with local governments to form the Spent Fuel Solutions coalition that advocates for policy reform. The Energy Council is in a position to help effect change.

Geothermal Energy

Mr. Steve Emmen Policy Advisor Western Governors' Association

In June of 2023, Western Governors' Association released the *Heat Beneath Our Feet* Chair initiative report, which examined the development and deployment of geothermal technologies in the West. Included in the report is recommendations for policy makers to accelerate the adoption of geothermal technologies. Mr. Emmen will discuss these recommendations, highlighting actions taken to implement them under the current administration and Congress. Additionally, he will outline opportunities for advancing these recommendations under a potential new administration and the 119th Congress.
